## SECTION E - DECLARATION

I understand that the ownership record is for Weatherbys' administrative purposes only and does not infer legal title and **is not recorded for racing or breeding purposes** for the aforementioned horse. I understand that my name and address will be entered in the passport when ownership is recorded.

I hereby agree to be bound by the Rules of Racing, as published by the British Horseracing Authority ("BHA") and as amended from time to time. I acknowledge that the Rules of Racing (including the Equine Anti-Doping Manual (G)) are available on the BHA's website at <http://rules.britishhorseracing.com/> and I have had full opportunity to review them.

I declare that the Horse has not been administered, nor has or could have ingested, any substances or methods listed in Schedule (G)1 of the Rules of Racing as being prohibited at all times at any point in its life to the best of my knowledge, save for in situations specifically permitted in that list for therapeutic use. I acknowledge that in the event that the above declaration is found to be inaccurate, misleading or fraudulent at any point in the future, the BHA may impose restrictions on the Horse as provided for in the Rules of Racing, including but not limited to preventing the Horse from entering races in Great Britain, preventing the horse from entering or continuing in training, and disqualifying the Horse from races already run.

I also acknowledge that an inaccurate, misleading or fraudulent declaration may result in the BHA taking disciplinary action against me.
